She will take you inside the cockpit of her A-10 Warthog during a harrowing mission when her aircraft was struck by enemy fire. Through this life-changing—and admittedly terrifying—experience, Kim shares why courageous leadership and teamwork are essential for elevating performance.

Leveraging her extensive experience as a fighter pilot and senior military leader, Kim unveils powerful insights into the mindset and culture that enable fighter pilots to sustain peak performance and make decisive choices under pressure. She

shares the value of creating a "wingman culture"—where trust, collaboration, and mutual support are essential to fostering high-performance teams. Packed with actionable strategies from the cockpit, this keynote invites you to explore a unique perspective on leading with courage and fostering resilience, equipping you to inspire bold action and elevate performance.

Kim "KC" Campbell is a retired Colonel who served in the United States Air Force for over 24 years as a fighter pilot and senior military leader. She has flown 1,800 hours in the A-10 Warthog, including more than 100 combat missions protecting troops on the ground in both Iraq and Afghanistan. In 2003, Kim was awarded the Distinguished Flying Cross for Heroism after successfully recovering her battle-damaged airplane after an intense close air support mission.

As a senior military leader, Kim has led hundreds of airmen both at home and abroad in deployed locations and enabled them to succeed in their missions. She has experience leading complex organizations and driving cultural change. Kim knows what it takes to be a successful leader, to inspire and empower high-performing teams to achieve success.

Kim is a distinguished graduate of the United States Air Force Academy. As a Marshall Scholar, she earned an MBA from the University of London and a Master of Arts in International Security Studies from the University of Reading in England.

Kim's Air Force assignments include leadership roles as a Group Commander, responsible for over 1,000 Air Force personnel in South America, Central America, and the Caribbean. She also served as the Military Assistant to the Under Secretary of Defense for Policy, advising the number three civilian official in the Department of Defense on national security and defense policy formulation. Kim has also served as the Air Force Senior Fellow at the Atlantic Council, a pre-eminent think tank promoting international leadership and engagement. Most recently, she served as the Director of the Center for Character and Leadership Development at the Air Force Academy.

Kim is now a keynote speaker and executive coach with Victory Strategies, a leadership development and coaching firm. She is the author of the bestselling book, Flying in the Face of Fear: A Fighter Pilot's Lessons on Leading with Courage.

The SAFE Association Awards Committee is now accepting nominations for the following awards, and we need you to help us identify deserving candidates. We invite you to review the criteria for each award and nominate a worthy colleague or team.

#### All nominations should be submitted by close of business July 17, 2025.

Nominations will follow the guidelines provided on the SAFE Association website, see <a href="https://safeassociation.com/">https://safeassociation.com/</a>.

Once received, the Board of Directors will evaluate each nomination based on relevance to the award criteria and the details of the supporting information provided in the submission. This ensures the awards go to the most deserving recipients.

To identify the most deserving recipients, we need your nominations! We all know of individuals across our industry with significant accomplishments over the past year or their entire career. Project and Program Teams that have made recent major contributions are also prevalent in the military, in new product development, contract service providers, and academic research communities.

The Award categories are:

#### MICHAEL R. GROST CAREER ACHIEVEMENT AWARD

Recognizes the career of a deserving individual for their significant contributions to the field of safety or survival.

#### GENERAL SPRUANCE INDIVIDUAL ACHIEVEMENT AWARD

Honors an individual who has made a recent outstanding contribution in the safety field through leadership toward or significant advancement of, safety and survival improvements. This contribution can be made through education, knowledge, science, application of investigative techniques, or engineering.

#### **TEAM ACHIEVEMENT AWARD**

Acknowledges the recent accomplishments of a team in the field of safety or survival through an advancement in education, knowledge, science, application of investigative techniques, or engineering associated with a significant improvement in safety or survival.

#### MERITORIOUS SERVICE AWARD

Is presented to the person or persons, civilian or military, who have demonstrated a recent outstanding contribution to the preservation of human life through an action of courage.

#### **MURRAY P. KOCH INDUSTRY AWARD**

Distinguishes a member of industry who has made recent significant contributions in the advancement of technology or hardware for safety and survival applications.

# **Election 2025 – Call for Nominations**

The SAFE Association was built, has thrived, and been sustained by the dedication and volunteerism of our members. Stepping up, pitching in, and collaborating with other like-minded volunteers to carry out the Associations goals and objectives is the engine that continues to drive SAFE's success. Each year a new Board comes together to build on the lessons learned and accomplishments of the Board that came before it.

The process for fielding Candidates for the Membership to consider and elect as Officers to the SAFE Association Board of Directors is an annual requirement under the Constitution and By Laws. Nominations for elected board positions are due to the Nominations Committee not later than July 1, 2025. Our goal is to have a vetted and Board-approved slate of Nominees no later than Friday, July 11, 2025. This targeted end date would ensure adequate time for the preparation of the on-line ballot and voting process. The results will then be presented at the last Board meeting before the 2025 Symposium in November. The 2025 SAFE Association election is set to open on August 1, 2025, and end on September 1, 2025.

#### Candidates are being sought for the following elected board positions:

- <u>President-Elect</u> Pre-requisite: Eligibility for nomination and election to the office of President-Elect shall require two years of continuous active membership in the Association and a minimum of one term as an elected or appointed member of the Board. The President-Elect shall ascend to the office of President upon the close of the 2026 SAFE Symposium. In the interim, the President-Elect shall be a member of the Board and performs such duties as delegated by the sitting President. Additionally, the President-Elect shall familiarize themselves with the duties of the office of President. In the event both the President and Vice President are incapacitated or otherwise unable to act, the President-Elect shall perform the duties of the President during the period of such incapacity or inability to act.
- <u>Vice President</u> No Pre-requisite. The Vice President shall be a member of the Board. The Vice President will familiarize themselves with the activities and duties of the President and will act as the Chairperson of the Finance Committee. If the President is not available to officiate, the Vice President will act during the vacancy. In the event the President shall become permanently unable to perform the duties of the office, the Vice President shall become the acting President.
- <u>Secretary</u> No Pre-requisite. The Secretary shall assist the Association Administrator or other Board member as directed in accordance with the procedures established by the Constitution and Bylaws, and shall assure the written record of the association is maintained and available to the members.
- <u>Treasurer</u> No Pre-requisite. The Treasurer shall oversee the Association's financial records in accordance with the procedures established by the Constitution and Bylaws and shall assure the issuance of at least one financial statement annually.

To be approved, each Candidate must be a current member in good standing to run for office.

We encourage you to consider volunteering your talents to be a Candidate by stepping up and pitching in with your creative, thoughtful and collaborative energies. Your participation clearly helps further the viability of the SAFE Association in its role of supporting, protecting and saving the lives of those who intentionally go out into harm's way.

Waldorf University is pleased to offer the annual Al Loving Scholarship in partnership with SAFE Association. This scholarship will be presented to one individual who demonstrates a passion for education and development, support of the SAFE Association and its affiliates/members, and the desire to achieve their educational goals.

The scholarship will cover up to 60 credit hours toward one online degree program at Waldorf University. It will be applied directly to the recipient's tuition for up to 36 consecutive months or until the completion of the selected online degree program, whichever comes first. Applications will be accepted from October 1 through December 31.

#### SCHOLARSHIP ELIGIBILITY

- // Waldorf will grant one scholarship to one member or volunteer of the SAFE Association.
- # Scholarship applicants must have a high school transcript or equivalent (GED).
- # Scholarship applicants must be able to maintain continuous enrollment in his or her degree program.
- // Capable of maintaining a minimum 2.0 undergraduate GPA and 3.0 graduate GPA.
- # Recipient must enroll within ninety days from the date of the award notification.
- // Must have a current application for admission to Waldorf University on file or be a current student (visit waldorf.edu/apply and select "online programs").
- // Applicants must provide verification for eligibility (acceptable verification documents include proof of membership to SAFE or a recommendation letter from a SAFE Member or Associate).

# **SAFE 2025 Call for Presentations**

The SAFE Association's Annual Symposium is the premier international showcase for unparalleled discovery including technical sessions, extensive exhibits, product demonstrations, workshops, technical debates, panel sessions, and networking opportunities. Areas of interest include, but are not limited to, the following:

#### **SUBMISSION GUIDELINES**

Briefings, Panels (consisting of 2 or more Briefings), Demonstrations & Workshops (specify). Submit a no-more-than 300-word abstract (electronically using the online abstract submission portal) to the SAFE Office through the SAFE website at www.safeassociation.com. Abstracts should be typed in 9pt Verdana font. A template is available for download on the website.

Abstracts must be submitted electronically using the entry form through the SAFE website, rather than via e-mail to the organization. Once submitted, a compiled abstract, as described above, is generated and e-mailed to the main (first) author and automatically forwarded for consideration to the symposium.

Technical Presentation abstracts should include Introduction, Methods, Results, and Discussion sections.

Panels, Briefings, Demonstrations, and Workshops should contain a paragraph outlining the safety issue to be presented, followed by a description of the program or product and how it is used to address the issue.

Panel sessions should outline the topic or scope, number of presenters by name and affiliation, and the panel chair. When planning a panel, bear in mind that session blocks are generally around 90 minutes. Panel sessions may list "tentative" speakers or papers for acceptance, but these must be finalized before the deadline.

You will be notified when your submission is accepted, rejected, or if revisions are required for acceptance. If your submission is rejected, you may resubmit with corrections and/or changes. Your presentation will be scheduled based on the type of paper and content.

#### **AUDIO-VISUAL PRESENTATIONS**

Presenters are to bring their presentation, formatted in MS PowerPoint (wide-screen 16:9 is preferred), electronically saved on appropriate media (memory stick, CD, etc.) directly to their session at least 20 minutes prior to the scheduled start. The program allocates time between sessions to accommodate uploading the session's presentations to available presentation equipment immediately before the start. Each presentation will be allotted a total of 25 minutes (20 minutes for presentation time followed by 5 minutes of Q&A). If presentation time exceeds 20 minutes, Q&A time will also be shortened to account for the time difference. Moderators will work to ensure sessions begin and end at the appropriate time.

All authors are required to attend the Author's Briefing to meet and coordinate with the symposium Technical Team, the session moderator, and session co-presenters. Any technical issues or needs will be addressed at that time.

The following presentation equipment will be available for all technical sessions: a laptop computer, projector, and screen with lectern and microphone as well as a LASER pointer.





- The next DoD Human Factors Engineering Technical Advisory Group (DOD HFE TAG) meeting (previously scheduled for 12-14 May 2025) has being postponed due to restrictions on government travel.....Stay tuned!
- Mr. Chris DeLuca (OUSDRE Director of Systems Engineering) met with a small group of industry society representatives in February to discuss cooperation on developing and revising human factors and Human Systems Integration (HSI) requirements. This should result in much improved coordination of DoD and industry requirements.
- The SAE International, G-45 Human Systems Integration committee is currently revising its standard (SAE1008) on Force Protection and Survivability. SAE is seeking assistance from survivability subject matter experts. Please contact Steve Merriman if interested.
- The Human Factors and Ergonomics Society (HFES) and SAE International have signed a Memorandum of Cooperation to coordinate activities related to human factors and HSI standards, and have held an initial meeting to identify initial shared activities.

#### The Current State of Aerospace & Defense Mergers and Acquisitions Market in 2025

The Aerospace and Defense (A&D) mergers and acquisitions (M&A) market has experienced a surge in activity over the past several years, driven by global geopolitical tensions, increased defense spending, and the prioritization of technological advancements. As governments worldwide bolster their defense budgets to address emerging threats and modernize military capabilities, companies operating in this sector have become prime targets for strategic acquisitions. Additionally, commercial aviation and rotorcraft markets are also experiencing a resurgence in M&A interest following the COVID "black swan event" as industry players look to capitalize on post-pandemic recovery, technological advancements, strong demand fundamentals for Maintenance, Repair and Overhaul ("MRO") services and a growing demand for efficient, next-generation aircraft. Notably across both Aerospace and Defense has been a key focus on the pursuit of businesses with highly engineered, proprietary content critical to key aircraft platforms or enhance the survivability and mission effectiveness.

#### **Increased Global Defense Spending as a Key Catalyst**

One of the primary drivers of M&A activity in the A&D sector is the significant increase in global defense spending. Nations such as the United States, NATO allies, and Indo-Pacific countries are investing heavily in next-generation capabilities, including missile defense, cybersecurity, electronic warfare, and space-based defense systems. This elevated spending has prompted defense contractors to pursue acquisitions that align with these high-growth areas, consolidating assets to achieve scale, synergies, and technological superiority.

#### **Prioritization of Highly Engineered, Proprietary Content**

Buyers in the A&D sector are increasingly focused on acquiring companies with proprietary intellectual property and highly engineered solutions. These assets provide long-term competitive advantages, strong contract positions, and higher barriers to entry, making them particularly attractive in an industry where differentiation is critical. In defense, companies specializing in radar systems, precision-guided munitions, mission-critical or flight critical components, communications, hypersonic technology, and electronic warfare solutions are particularly sought after due to their strategic importance in modern combat scenarios. Furthermore, businesses with long-term production contracts and sole-source supplier status to major defense programs command premium valuations in the current market environment.

#### **Focus on Survivability and Mission-Critical Capabilities**

Another prominent theme in A&D M&A is the growing emphasis on survivability and mission-critical capabilities. With the evolving nature of warfare and the increasing sophistication of adversarial threats, defense contractors are actively seeking companies that enhance force protection, counter-drone technology, electronic countermeasures, and battlefield resilience. These assets are particularly valuable in contested environments where survivability can dictate mission success. The recent trend of acquisitions targeting firms specializing in stealth technologies, active protection systems, and secure communications underscores this priority.

#### **M&A Opportunities in Commercial Aviation**

The commercial aviation sector is also seeing renewed M&A interest as airlines and aircraft manufacturers seek to modernize fleets and improve operational efficiency. Post-pandemic recovery, sustainability initiatives, and increasing passenger demand have driven investments in next-generation aircraft, fuel efficiency technologies, and advanced avionics. Companies specializing in aerostructures, composite materials, and digital flight solutions have become attractive targets for acquisition as the industry shifts toward more fuel-efficient and environmentally friendly aircraft.

#### **Rotorcraft and Helicopter Market Consolidation**

The rotorcraft and helicopter segment is undergoing significant consolidation as defense and commercial operators seek to modernize fleets and expand capabilities. Increased demand for vertical lift aircraft in both military and civilian applications, including emergency medical services, law enforcement, and offshore energy transportation, has driven M&A activity. Companies with proprietary rotorcraft technologies, lightweight materials, and advanced avionics systems are being actively pursued by major aerospace players looking to enhance their vertical lift portfolios.

#### Strong Demand for Commercial Aerospace M&A

As Boeing and Airbus work to normalize supply chains and ramp up production, the commercial aerospace sector is experiencing heightened M&A interest. With record-breaking order backlogs, major aircraft manufacturers are prioritizing the stabilization of their supplier ecosystems, presenting opportunities for consolidation within the supply chain. Companies specializing in aerostructures, components, and high-value subsystems are becoming prime acquisition targets as OEMs seek to mitigate risks associated with production delays and enhance manufacturing efficiencies. The continued operation of aged fleets is also driving significant M&A activity in the maintenance, repair, and overhaul (MRO) and aftermarket segments. Airlines are extending the life cycles of their existing aircraft due to high replacement costs and supply chain constraints on new deliveries. As a result, MRO providers, spare parts suppliers, and component repair companies are seeing increased demand, making them attractive targets for both strategic buyers and private equity investors looking to capitalize on long-term aftermarket growth. Moreover, supply chain consolidation remains a focal point for aerospace M&A as companies look to secure reliable access to critical materials and reduce production bottlenecks. Vertical integration strategies are being pursued by aerospace primes and Tier-1 suppliers to enhance supply chain resiliency and mitigate reliance on third-party vendors. This trend is expected to persist as the industry continues its post-pandemic recovery and positions itself for sustained production increases in the coming years.

#### Industry Consolidation and the Role of Private Equity

The A&D sector is witnessing continued consolidation as both strategic buyers and private equity investors seek to capitalize on growth opportunities. Large defense primes are rationalizing their portfolios, divesting non-core assets while simultaneously acquiring high value, differentiated capabilities. Meanwhile, private equity firms, recognizing the stability and long-term government funding inherent in the defense sector, have been aggressively deploying capital to acquire and consolidate middle-market defense suppliers. This consolidation trend is expected to persist, driven by the need to streamline supply chains, improve operational efficiency, and position companies for sustained growth in an evolving defense landscape.

The A&D M&A market remains highly active, fueled by increased global defense spending, the demand for highly-engineered, proprietary content, and the focus on survivability and mission-critical solutions. In addition, opportunities in commercial aviation and the rotorcraft segment are expanding as industry players look to modernize and capitalize on technological advancements. As geopolitical tensions continue to shape defense priorities, strategic buyers and financial investors alike will pursue opportunities to strengthen their market positions through acquisitions. The ongoing consolidation of defense assets underscores the industry's commitment to innovation, efficiency, and enhanced capabilities, ensuring that M&A activity remains a pivotal strategy for growth in the A&D sector.
